# Palestine Residents Look to Expand Community Philanthropy

East Texas Communities Foundation (ETCF), which provides services in a 32-county area of northeast Texas, including Anderson County, has been chosen to provide charitable fund services to individuals and organizations in the Palestine area who originally established their funds with the Texas Area Fund Foundation (TAFF).

"The board of TAFF is confident that the residents of our community and the donors who have entrusted TAFF with their charitable resources will be served well by the new arrangement with ETCF," said TAFF President Jackson Hanks.

Since it was established in 1999, TAFF has assisted local residents with the creation of charitable funds to meet their personal philanthropic objectives and address important community needs. Partnering with ETCF to manage those funds is meant to boost local charitable giving with new fund options, professional staff, more investment options and modern conveniences such as online charitable fund access and online scholarship administration.

"We are committed to providing personal service for donors and nonprofit organizations in Anderson County and beyond who are looking for an effective and efficient solution for their current and future charitable giving," said Kyle Penney, President of ETCF. "We are thrilled to work with TAFF fund holders to transition their funds to our platform and look forward to helping them reach their charitable giving

objectives."

ETCF was established in 1989 and has grown to over \$90 million in charitable assets with almost 300 unique funds. Each charitable fund has a specific objective established by the donor to benefit the charities which are most important to them. The most common funds at ETCF are donor-advised funds, which are often established by individuals as a simple and low-cost alternative to creating a private foundation. Donors set up their fund and are given an immediate tax deductible benefit, since ETCF is a 501c3 public charity. Once the fund is established, donors can recommend grants to any US-based public charity.

Another popular fund option at ETCF is the scholarship fund. Donors can set up a scholarship to benefit students from a certain geographical area, going into a certain field of study or attending a specific college or university. ETCF provides an online application process, reviews the applications and notifies the lucky recipients.

"We appreciate the hard work of TAFF volunteer board members such as Cad Williams, Jackson Hanks, Jo Ellen Walley, David Barnard and Ahnise Summers who have worked tirelessly and without compensation to grow TAFF to its present level," said Penney. "We are sincerely honored that the board of TAFF has chosen ETCF to receive these trusted charitable resources and we are committed to helping them grow and support the important work of charities in this community."




