ETCF Ends 2022 Granting \$12.3 Million

East Texas Communities Foundation awarded more than \$12.3 million in grants to over 800 different nonprofit organizations in 2022.

"ETCF is honored to connect generosity with need," said Kyle Penney, President of East Texas Communities Foundation. "Thanks to the support of our donors and the work of dedicated and talented nonprofits, we are able to fund solutions that address community needs."

Most of the grants benefited nonprofits in ETCF's 32 county service area that includes: Anderson, Angelina, Bowie, Camp, Cass, Cherokee, Delta, Franklin, Freestone, Gregg, Harrison, Henderson, Hopkins, Houston, Lamar, Leon, Marion, Morris, Nacogdoches, Panola, Rains, Red River, Rusk, Sabine, San Augustine, Shelby, Smith, Titus, Trinity, Upshur, Van Zandt and Wood counties.

The top categories were Education (31%), Health (20%), and Religion (17%).

"ETCF is proud to see the community continue to prioritize charitable giving," said Penney. "We know with todays market ups and downs that nonprofits are trying to stretch each dollar gifted to them. We look forward to providing grants in 2023 while working closely with donors to reach their charitable goals."

In addition to the generous grantmaking seen in 2022, ETCF fundholders contributed more than \$12 million for future charitable giving. ETCF ended the year with \$115 million in charitable assets under management.

ETCF enters 2023 stewarding more than 430 unique charitable funds, established by individuals, families, corporations and nonprofit organizations.

Plunkett Foundation Awards Grants to Nonprofits Serving East Texas

Fifteen nonprofits serving Gregg, Nacogdoches, Rusk, and Smith counties were awarded grants totaling \$110,000 from the T.J. and LaVerne Plunkett Foundation held at East Texas Communities Foundation in Tyler, Texas.

Gregg County nonprofit, Family Promise of Longview, received funding to provide rent and utility assistance to families.

"This grant will be put to use immediately," said Doris Ramaly, Executive Director of Family Promise of Longview. "Thanks to this grant, we will provide up to \$1,000 per family to those that are at risk or on the verge of homelessness. In addition to funds, we will provide clients' money management training, life skills and educate them on the *Keys to Good Tenancy*."

Families receiving financial support will have the funds paid directly to the property owners or utility companies.

"We have seen a 37% increase in just the past nine months from families needing this safety net," said Ramaly. "The rising cost of gas, food and rent on low-income families is staggering. Many are just one crisis away from being on the streets. Since we can only provide financial assistance once to a family, it is really important to get them back on track, managing the resources they have so they don't end up homeless."

Founded in 2004, Family Promise of Longview works to break the cycle of poverty by helping families with children experiencing homelessness achieve long-term financial independence.
