## ETCF Ends 2023 Granting \$13.6 Million

East Texas Communities Foundation awarded more than \$13.6 million in grants to over 800 different nonprofit organizations in 2023.

"ETCF is honored to connect generosity with need," said Kyle Penney, President of East Texas Communities Foundation. "Thanks to the support of our donors and the work of dedicated and talented nonprofits, we are able to fund solutions that address community needs."

Most of the grants benefited nonprofits in ETCF's 32 county service area that includes: Anderson, Angelina, Bowie, Camp, Cass, Cherokee, Delta, Franklin, Freestone, Gregg, Harrison, Henderson, Hopkins, Houston, Lamar, Leon, Marion, Morris, Nacogdoches, Panola, Rains, Red River, Rusk, Sabine, San Augustine, Shelby, Smith, Titus, Trinity, Upshur, Van Zandt and Wood counties.

The top categories were Education (31%), Health (20%), and Religion (17%).

"ETCF is proud to see the community continue to prioritize charitable giving," said Penney. "We know with todays market ups and downs that nonprofits are trying to stretch each dollar gifted to them. We look forward to providing grants in 2024 while working closely with donors to reach their charitable goals."

In addition to the generous grantmaking seen in 2023, ETCF fundholders contributed more than \$10.3 million for future charitable giving. ETCF ended the year with \$133 million in charitable assets under management.

ETCF enters 2024 stewarding more than 475 unique charitable funds, established by individuals, families, corporations and nonprofit organizations.

## **Plunkett Foundation Awards Grants to Nonprofits Serving East Texas**

Thirteen nonprofits serving Gregg, Rusk, Smith and Upshur counties were awarded grants totaling \$85,000 from the T.J. and La-Verne Plunkett Foundation held at East Texas Communities Foundation in Tyler, Texas.

"The Plunkett Foundation has a generous history of supporting East Texas charities," said Kyle Penney, President of East Texas Communities Foundation. "We are honored to continue their work making grants to worthy nonprofits serving our neighbors in need."

Gregg County nonprofit, Legacy Closet of Longview, received funding to provide car seats to foster families.

"This grant will be put to use immediately," said Angela Dean, Board President of Legacy Closet of Longview.

"Children often arrive into the care of a foster family with little to nothing in the way of supplies. One of the most immediate needs for a foster family is a car seat to transport the child safely to appointments. Generous funding from the Plunkett grant will cover the cost of purchasing new car seats for families over the upcoming year.

Legacy Closet of Longview, through the help of volunteers, offers families a "closet" with clothes, shoes, baby gear, cribs, car seats, toys, school supplies and other items kids need when placed into foster care.



Take a look at what is happening around East Texas. The pictures below represent just a few of the ways fundholders are investing in our communities through ETCF.



Arts & Culture: The East Texas Symphonic Band, under the direction of Dr. James Snowden, performed a free concert at Teague Park Amphitheater in Longview, Texas. The concert was made possible in part by a grant from the Evans-Merrick Music Grants Fund.

Humane Services: The King's Rein, located in Larue, Texas, engages equines to help restore people's mental and emotional health, develop self-worth, trust and discipline. A recent grant helped the organization complete their tack room.



**Community Development:** The Greater Longview United Way partners with 20 local agencies that operate 37 programs addressing basic needs within the community. The United Way offers tax assistance for low-income families and prescription drug discounts to ease health care costs.



Human Services: National Adoption Day is observed on November 18th of each year. A grant to the The Smith County Young Lawyers Association, provided lunch and gift baskets to the families of children adopted into their forever homes.





Human Services: Bethesda Health Clinic received a grant to assist with prostate cancer care, education and awareness, and free Prostate Specific Antigen (PSA) screenings. Prostate cancer is the most commonly diagnosed cancer in men after skin cancer.
